Welcome and Introductions (Becca Geller-Puchalsky)

Review and Approval of Meeting Minutes (November) – deferred to February

Speakers

- Nate Hommel of University City District (UCD) to talk about a <u>Pedestrian Plaza</u> application at 43/Spruce
 - Been experimenting with this. On old UCD plazas, goal was for place for people to hang. Some of our other ones, materials and things that were used, 2012 now 11 years old, still look pretty good. Utilities have had to take things up, and still had improvements.
 - Will try something they want to try to make it more sustainable from a
 maintenance standpoint self-watering planters that has advanced pretty far in
 the last couple years. All the things we have learned at UCD public spaces use
 non-permanent rather than temporary or pop-up. Allows for flexibility.
 - o Perfect is the enemy of done ©
 - What is the thing we can do to reduce distances for pedestrians to cross when they worked with OTIS what are some of the things that handcuffed them
 - Simple things 7 feet off the curb not going to do too much not going into drive aisle.
 - Bike lane still there
 - 20 feet off the crosswalk, hoping to replicate all over U City
 - See plan below exactly the same as it was OTIS said don't do anything near
 the SEPTA bus stop but do have a couple things to give it elevation. Since it is
 just paint and planters (can't do boulders because need to be able to move them
 on short notice). Flexible delineator sticks. Flex posts.
 - The Field Could have kids from the school do anything [as far as decorating] in there.
 - Planters if a vehicle hits them what happens? They bounce, they don't break. Things that bounce last a lot longer.
 - Safer than before.
 - 14 less feet than typically crossing where potentially being impacted by a motor vehicle
 - Small planters are where a turning vehicle might encounter a small child

- Large planters are end caps things that driver sees, signals to drivers that this is intersection they need to pay attention to
- Step in the right direction candidacy for permits. If the neighbors like it, can keep it. If everyone loves it, then can aim for permanency. Can be improved over time.
- Cost would be folded into maintenance. \$15-20K range. Community paying for paint. From a numbers standpoint had a private design firm after that got it down to \$12K. Can come up with 5K
- o This is a regulated program, UCD insurance would cover it. Can depend on UCD that going to keep going with this.
- Vision Zero in line with what the city wants to do to help keep pedestrians getting hurt.
- o Asks for SHCA:
 - Letter of support actually letter of non-opposition
 - Fundraising yes, UCD can put in up to 5K
 - Contribution?
 - Working with whomever want to work with?
- o Safety walks PAS, PIC, Penn so may have other community partners
- o Q&A
 - Community member lives right in front says there is a zip car parking space there? Also says we should slow down the traffic anyway. Planters good. Slowing down. Becca School has promised speed bumps on spruce, 43rd, locust, blocks surrounding the school.
 - Eric survey on retail in the neighborhood looking for someone to partner. He is not the person for this, but Ryan Spak would do this.
 - Yoni appreciates responsiveness to put this together, would be huge improvement of quality of life. Would like to see more. But on the opposite side, people will zoom around. Can do floating bus stations? Nate yes, maybe city has discussed partnering with UCD on this. Zero entrance bus? SEPTA bus is a limiting factor.
 - Trying to do little bits at a time.
 - How about at 43rd & Baltimore? Maybe let Nate know.
 - Bridgette would these be native plants? Yes, or sometimes use adapted plants – tough as nails and bees love it. Stays away from ornamental flowers.

Committee Updates

- Executive Committee (Becca Geller-Puchalsky)
 - o Nothing from exec.
 - o Comments about supporting the pedestrian plaza
 - Motion to approve pedestrian plaza seconded and then approved
- Historical Preservation Committee (Jenine Sanzari)
 - O Julie Context Magazine Julie is co-editing this the topic is historic preservation. John Pullman and others to write. Spring 2024.
 - Jenine current submission or application. No news from the historical commission doesn't mean anything. But gauging the timeline.
 - There are two public meetings that need to take place
 - Public forum every one, every resident in that first quadrant will be notified by a mailing, sent to the resident of the property owner – that is sent out by the historical commission. Constant Springs will be on the call.
 - That will be the final stamp of approval

- April agenda for that first meeting if in an April timeframe for that meeting, then wont have a response until may or June of this year
- Jenine second question \$ and budget funding the subsequent quadrants will cost a total of \$45K. They would be ready to submit a quadrant per year, based on how fast we are fundraising
- Zoning (Barry Grossbach)
 - O Zoning meeting is January 18th not a lot of activity because the council persons requirement of 10 units of affordable housing
- Safe Streets & Commercial Corridors (Evan Johnstone & Eric Santoro)
 - o 7 attempted car jackings
 - o Captain Nicole McCoy from Penn police no longer with the department
 - They haven't filled the position
 - Evan part of our responsibility is to determine what can be done what can we do.
 - Also 18th district PPD get them to speak.
- Education (Becca Geller-Puchalsky)
 - o Closing quite a few achievement gaps
 - Poverty rate is increasing at PAS
 - School has a 50% poverty rate Becca has been looking at census data from the managing directors office. In children in PHL in general.
 - o A tiny piece to that official what they count as poverty and nonpoverty
- Operations (Tony)
 - o Tidy up the paperwork
 - o Glitch in the calendar will figure out.
 - o Tony wants to go through the building piece by piece. Rich G.
 - o Renters building is full
- Community Engagement –Vicki stepped down as chair nothing to share need a new chair
- Spruce Up Committee (Laura Line) confirm if Laura still chairing
